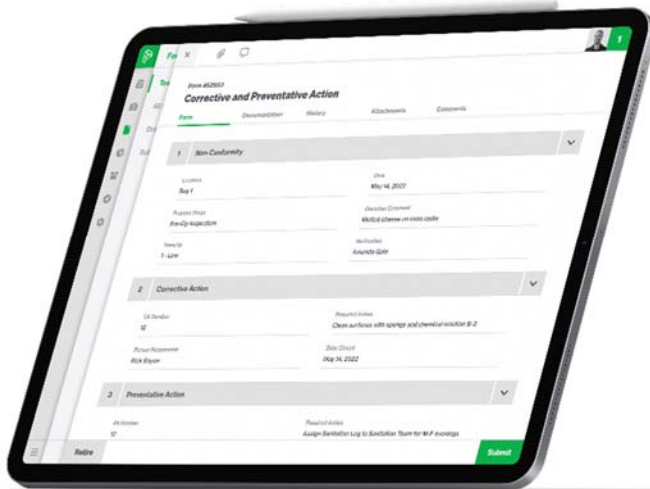

Provision's software platform allows agri-food businesses to manage all their food safety plans, records, and procedures digitally and achieve full traceability within one system. The project will develop a complementary practitioner management system – Provision Partner. This add-on will allow consultants to remotely access clients' operational information for the development and revision of food safety plans, and creation of reports required to manage quality assurance. It is expected that this program will reduce the time to develop a facility specific plans from 3-6 months to less than 1 month. Provision Partner will also allow automatic configuration of traceability across the entire production process and supply chain. This will ensure quick and accurate tracking and a more streamlined supply chain management system to minimize food loss, manage recalls, and increase consumer confidence.
