#### THE PROBLEM

Many health conditions can be improved by focusing on a few core components of health and wellness - namely nutrition, fitness, and mental health. However, committing to making lifestyle changes aimed at improving one's health can be challenging. Not only do people need access to trustworthy, evidence-based information, they also need to feel supported when embarking on a health journey. Literature shows that peer support is critical for reaching long-term health goals, and the medical system struggles to provide the level of support and connection individuals require to shift their behavior. In addition, healthcare providers feel overworked and burnt out. Chronic illnesses ranging from cardiovascular disease to type 2 diabetes continue to weigh on the healthcare system. There is also a lack of accountability to one's health goals as most people do not have the resources for daily check-ins with a dietician or psychologist making it easy to revert to old habits.

#### THE SOLUTION

Yaro – My Viva's new, innovative product – is a conversational health buddy who provides an engaging way to interact with digital health apps. Through natural verbal conversation with an augmented reality avatar, users complete their daily reflections with Yaro and collect rewards. Users are more likely to engage with their health app through natural motivation with aspects of gamification and a 24/7 accountability buddy. With My Viva's core digital health product, My Viva Plan helps people take control of their health. As the first adopter of Yaro to increase adherence and retain subscribers, My Viva hypothesizes that Yaro will increase the frequency of daily reflections resulting in improved health outcomes, higher app usage, and more retained subscribers. Health outcomes and self-efficacy will be measured by physical and mental health self-assessments, validated psychological assessment scales and biometric data specific to individual diseases. Key performance indicators, including app retention and usage frequency, will be collected as evidence of validation for health platform customers.
